## **Upper Greenbrier North Project** Decision Notice and Finding of No Significant Impact #2

I am writing to inform you of my latest decision for the Upper Greenbrier North (UGN) project. On March 5, 2012, I signed a Decision Notice and Finding of No Significant Impact (DN/FONSI) to implement the Selected Alternative, a modification of Alternative 5 in the UGN Environmental Assessment (EA). The UGN project area is located on the Greenbrier Ranger District, in the upper part of the Greenbrier River watershed, in Pocahontas County, West Virginia. A large project area was chosen to allow better consideration and analysis of cumulative impacts and landscape ecology factors such as spruce-hardwood ecosystem connectivity, age class distribution, and watershed improvement needs and opportunities.

My March 5, 2012 decision was appealed by Friends of Blackwater. As part of the appeal resolution, the Appeal Deciding Officer (MNF Forest Supervisor, Clyde Thompson) reversed the March 5, 2012 UGN DN/FONSI in a letter to the appellants dated June 6, 2012. Since then the MNF has been working to address applicable appeal points and recommendations from the Appeal Reviewing Officer and appellants.

Based on this work, I issued a corrected EA and a new decision on August 15, 2012. That decision authorized implementation of: road and trail decommissioning and road maintenance for watershed restoration; restoration of aquatic and riparian habitat and aquatic passage; recreation improvements; and prescribed burning. This decision was not appealed and we are now beginning to implement some of the activities.

I am now issuing a second DN/FONSI approving more of the activities for that project that were analyzed in the corrected EA. This second decision authorizes implementation of activities designed to restore spruce and spruce-hardwood ecosystems within the UGN landscape, including commercial and noncommercial spruce restoration, spruce thinning, timber stand improvement, nonnative invasive plant species treatments, and road work. These activities will help meet desired future conditions described in the 2006 Monongahela Land and Resource Management Plan. Updated in 2011. At least one more decision on the hardwood timber harvest activities in the UGN EA can be expected following more discussion with the appellants.
